### 1 $\alpha$ Bisabolol

A sesquiterpene alcohol with a fragrance that can be described as floral, peppery, sweet and clean. Found in chamomile, figwort, yarrow, skullcaps, lavender, ironwort, germander...etc.

### 2 Geranyl Acetate

A monoterpene ester with a fragrance that can be described as floral, fruity, waxy and herbal. Found in lemongrass, palmarosa, geranium, sassafras, carrot, coriander, bitter orange, Camden woollybutt...etc.
